3. Minutes of the Previous Meeting

The minutes of the previous annual general meeting on 30th June 2019 will be agreed and signed at the next Church Council due to COVID restrictions.

4. Presentation of the Annual Report for 2019/2020

Annual report- Ian commented that there had been some contact with members throughout Covid 19 lockdown but the report reflected the wider, whole church business.

Financial Report. – Richard said that there had been a modest loss of income due to lockdown and the only stream of letting at present was from the playgroup, who have a license agreement. Rental income would potentially be £4000 less this year.

There was no collection of money or envelopes as the church opened for the first service last week amidst Covid restriction regulations, but it was felt that a plate could be left out for envelope giving. Richard offered to have the plate sit for 72hrs at his house before counting and banking the money.

It was recognised that Brian had, as always, done a wonderful job of managing the finances and All Saints acknowledged their grateful thanks for this, along with the help of the finance group.

Ian thanked David Perrow for the hard work that he had put in into reopening the church in line with COVID guidance regulations. He had kept on top of the frequent government changes and the congregation had been delighted to meet again, despite restricted numbers. Thanks were given to the stewards and ushers for implementing the risk assessed rules and now that alterations had been discussed the procedure should flow more smoothly. All notices about COVID restrictions could be found on the notice boards.

Ruth Coward was thanked for her time as stewards. All Saints had been grateful for her volunteering and recognised her many skills and input, especially to CribFest.
